

# Welcome Fund Membership Application

The Welcome Fund/Subsidized membership serves families with dependent children up to 8 years old. To obtain a Welcome Fund membership, applicants must meet the following criteria:

- Children, birth to 8 years old, must reside in the same household with the parent or legal guardian.
- Applicant must meet the Income Eligibility Guidelines for free meals as defined by the United States Health and Human Services (please see the second page of this application form for guidelines).
- The applicant must also be a resident of Douglas, Sarpy, or Pottawattamie counties.

**To apply for a Welcome Fund membership, please submit a copy of ONE of the following documents with this application and \$5.00 payment:**

- A copy of the most recent income tax return **for each adult** on the application stating Adjusted Gross Income (AGI). *Your Adjusted Gross Income must be at or below the guidelines listed on the second page of this application form to qualify for a Welcome Fund membership.*

**-OR-**

- A copy of the letter from your child's school in Nebraska or Iowa notifying you that your child qualifies for the **free** school lunch program. *Reduced lunch does not qualify.*

information on other accepted documents. **OCM does not accept Medicaid cards, pay stubs, or Social Security benefits report as proof of income.**
