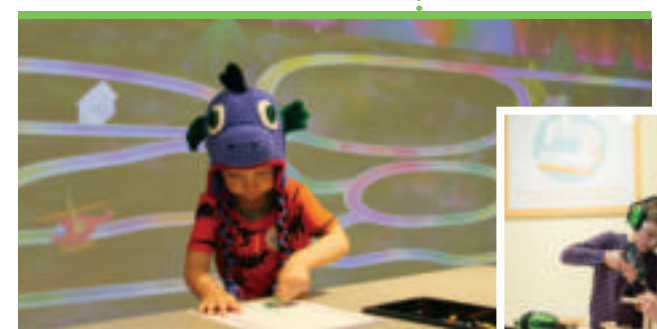

Capitalizing on priceless family time, the exhibit offers new spaces to play, build and dance together.



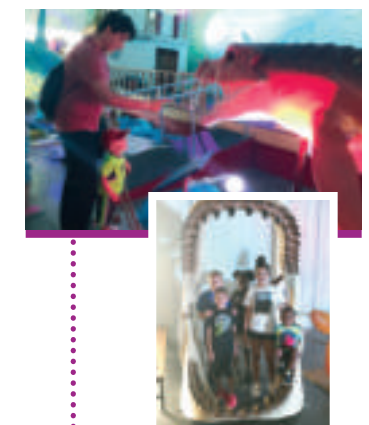
TINKERFEST

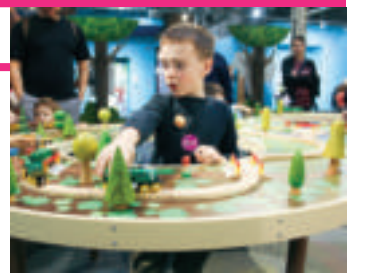
By adopting sensory-friendly practices, the museum became an even more welcoming place.

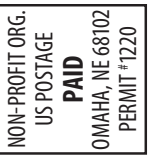
